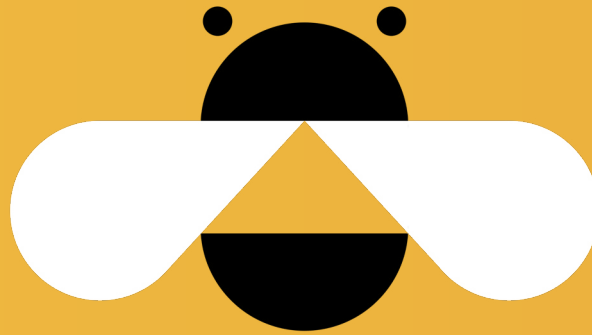
Well
