What are Terms & Conditions?

Terms and conditions set out the legal basis on which people are permitted to access and use your website.

What are they used for?

A basic set of terms and conditions will deal with what visitors to your website can:

- do when accessing your website;
- do with the intellectual property on your website; and
- disclaim liability for use of your site (amongst other things).

Do I need them?

Yes, they are needed to fulfil your legal obligations and manage your potential liability exposure, for example, where users rely on the content on your site. Terms and conditions will also help you to protect the intellectual property rights that exist in your site.

Can I copy from another website?

No, terms and conditions are protected by copyright, so if you copy and use them from other websites then this is likely to constitute copyright infringement. The terms may also not be appropriate or reflect what your website does and may be poorly drafted.



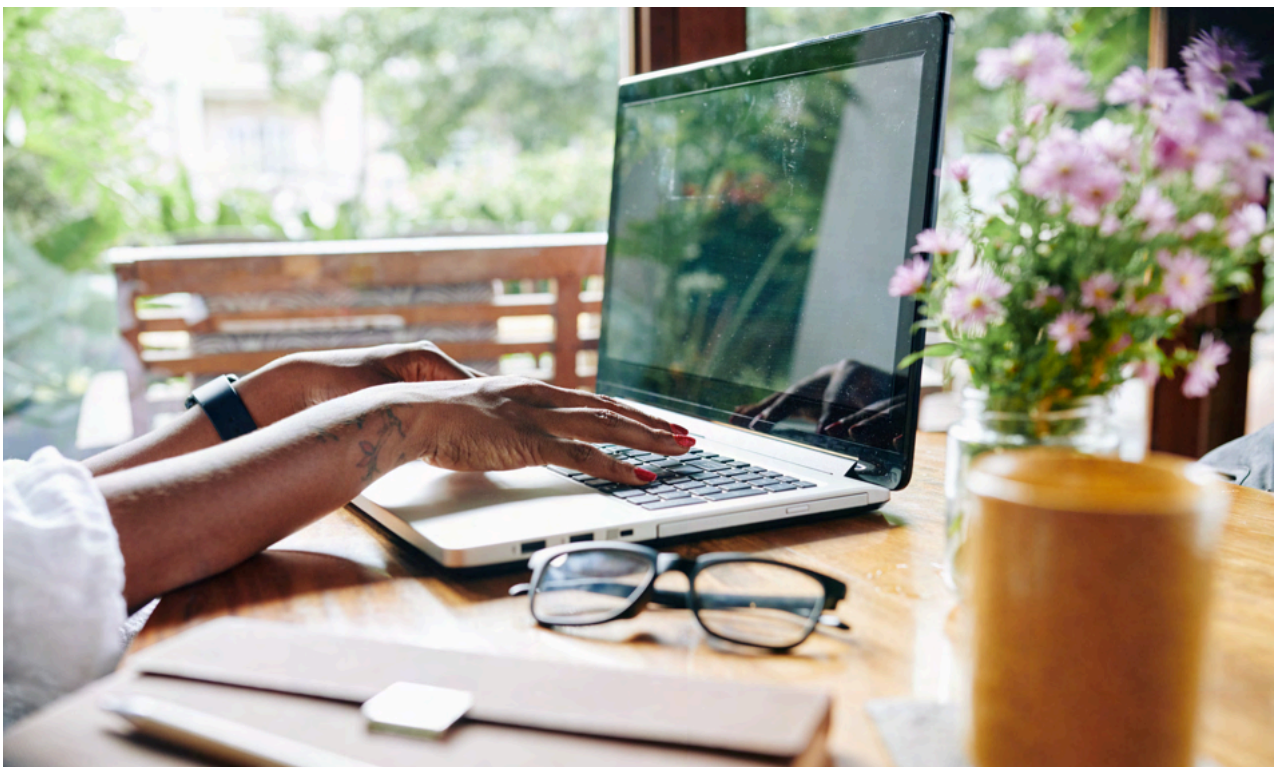
What are the legal requirements?

The legal requirements for your website will vary depending on the functionality and content of your website.

- If you collect personal data via your website or if you use cookies on your website, you will need a privacy notice and cookies notice and may also need appropriate consent from site users;
- If you sell goods, services or digital content through your website then you will need terms and conditions for the supply of the goods or services; and
- If you supply these to consumers then they need to comply with consumer law.

How can I get the right terms and conditions for my website?
